Trial Field: 6741 Paxton Valley Road (Signs will be posted)

Directions from Hwy 97 (Hwy that runs from Kamloops to Vernon)

Go north on Chase Falkland Road from Hwy 97 (in the center of Falkland on 97 between Ranch Café and General Store) for approx. 13 km. Go past Pillar Lake (do NOT take the first turn off sign for Paxton Valley at 6 mile BEFORE Pillar Lake). Take first left past Pillar Lake on Moser Rd.(mailboxes on corner). Go 2.5 km to T intersection and turn left and cross cattle guard. Trial field will be on the right side, camping on left.

Directions from Hwy 1 at Chase

Just west of Chase watch for Chase Creek – Shuswap Rd. (turns into Chase Falkland Rd). Go for 27 km. to Paxton Valley Rd. (when you see a very large equestrian center, jumps etc. you will then see only wooded area for a few km. before you see Paxton Valley Rd.) Turn right and watch for Trial signs. Trial Field is after the first cattle guard crossing. **This road has about 15 KM of gravel at the end. Trial field on right, camping on left.

Course: ISDS style field course

Start Times: ProNovice - 2 trials Saturday; Nursery - 2 trials Saturday; Open - 1 trial Sunday and 1 trial Monday

Awards: Daily Cash to 4 Pay-outs. All money paid out after Expenses

Small concession on site – Social Night Saturday – If weather permits we will bring the fire pit up (No handler's dinner)
