You must enter by Aug. 8, 2010. Qualifying trials include EID & Shaunavon trials 2010.

Maple Creek Open and Nursery are USBCHA & SSSA approved & are open to all dogs.

Dogs not qualified for the WCF are not eligible to run in the double lift finals.
